## **Submissions:**

As an applicant for the above awards, please submit a recent photo, proof of Bermudian citizenship/status, a copy of your acceptance letter to an accredited dance programme, a letter of recommendation from a current dance teacher, and a one page written statement including the following information:

- 1. A list of your qualifications;
- 2. Why you feel you are a good candidate for this award;
- 3. A description of the programme to which you have been accepted, including an explanation of the benefits of attending this particular programme.

## **Conditions of Awards**

- 1. All applicants must be Bermudian citizens or possess Bermudian status.
- 2. Applicants must be accepted into a professional programme overseas before receiving funds.
- 3. Finalists are required to appear before the NDFB Scholarship Committee (or by conference call if overseas) for an interview. They may also present supporting material, e.g. video of personal choreography, video of teaching ability, additional recommendations at that time. The time, date and location will be announced.
- 4. The successful applicants will acknowledge the National Dance Foundation of Bermuda's assistance in any public presentation, online or print format.
- 5. Recipients will provide two updates (by December 31, 2012 and June 1, 2013) that include mid term grades, teacher comments and other relevant information about their progress at school.
- 6. During the 2012-2013 academic year, recipients must agree to participate in at least two activities on a volunteer basis related to the National Dance Foundation
- 7. All applications must be completed and received in full, including required documentation and a recent photo, no later than Friday, June 15th, 2012.

Funding will be provided in two installments: August 17, 2012 and January 4, 2013. The second installment is contingent upon the receipt of the first progress report and the completion of at least one promotional activity.
